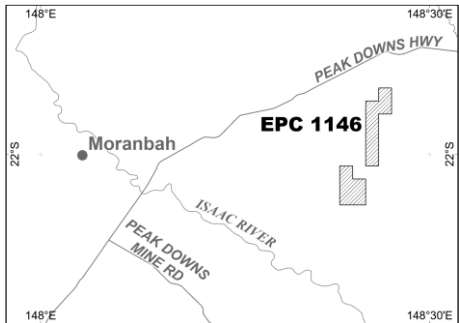


NOTICE OF PROPOSED RENEWAL OF EXPLORATION PERMIT FOR COAL

NATIVE TITLE ACT 1993 (CTH) SECTION 29

The Queensland Minister for Resources and Critical Minerals, PO Box 15216, City East, Queensland, 4002, hereby gives notice in accordance with section 29 of the *Native Title Act 1993 (Cth)* of the proposed renewal of Exploration Permit for Coal (EPc) shown below, subject to the provisions of the *Mineral Resources Act 1989 (Qld)*.

EPC 1146 applied for by FITZROY COAL EXPLORATION PTY LTD, ACN 108 568 725, over an area of 12 sub-blocks (38 km²), centred approximately 37 km east of Moranbah, in the locality of Isaac Regional Council.



Nature of Act(s): The renewal of an Exploration Permit for Coal under the *Mineral Resources Act 1989 (Qld)* authorises the holder to mine and carry out associated activities subject to the *Mineral Resources Act 1989 (Qld)* for a term not exceeding five (5) years, with the possibility of renewals for terms not exceeding five (5) years. It is proposed to renew the Exploration Permit for Coal subject to the *Mineral Resources Act 1989 (Qld)* and the Native Title Protection Conditions.

Name and address of person doing acts: It is proposed that the Exploration Permit for Coal be renewed subject to the provisions of the *Mineral Resources Act 1989 (Qld)* by the Queensland Minister for Resources and Critical Minerals, PO Box 15216, City East, Queensland, 4002.

Native Title Parties: Any person who is or becomes a 'native title party' within the meaning of the *Native Title Act 1993 (Cth)* is entitled to the negotiation and/or procedural rights provided in Part 2, Division 3, Subdivision P of the *Native Title Act 1993 (Cth)*.

Expedited Procedure: The State of Queensland considers the renewal of the Exploration Permit for Coal to which this notice applies, is an act attracting the Expedited Procedure. The Exploration Permit for Coal may be renewed unless, within a period of four (4) months after the Notification Day a native title party lodges an objection in respect of the individual Exploration Permit for Coal with the National Native Title Tribunal against the inclusion of the statement that the State considers the grant of that Exploration Permit for Coal is a future act attracting the Expedited Procedure.
